

APPENDIX 4C COMMENTARY Quarter ended 31 March 2018

Highlights

- Successful test assembly of key modular and structural components achieved
- Manufacturing of key components for the project has commenced to meet the forecast construction program
- Cash reserves of \$4.9m as at 31 March 2018.

PERTH AUSTRALIA, 30th APRIL 2018: Parkd Group Limited ("Parkd" or the "Company") (ASX:PKD), an innovative construction technology company, is pleased to report on its activities for the quarter ended 31 March 2018.

Parkd's focus during the quarter was primarily on progressing the Perth City Subaru project, Parkd's first major build using the Company's modular car parking system to create a 49 bay, single-level facility. Key activities on the project included:

- Engagement of the project builder, Integria Construction and other key sub-contractors and suppliers. An important criteria when selecting our partners on this contract was their ability to work on future projects on a national basis;
- Completion of successful manufacturing trials of the core structural elements demonstrating the ability of the manufacturing processes to meet required tolerances and specifications;
- Successful test assembly of key modular and structural components achieved. The tests were carried out to optimise the assembly process and mitigate construction risk; and
- Top tier manufacturers Civmec, Delta Precast, Speedfloor Australia and RECO commenced the manufacturing process of the key structural elements to meet the forecast construction program

Operating cashflow outflows totalled \$482k for the quarter ended 31 March 2018 with the Company having cash reserves of \$4,900k at the end of the period. Cashflows are expected to increase in the quarter ended 30 June 2018 as construction activities with the City Subaru project commence.

The Company also notes that Executive Director Mr McGregor Thom resigned as a Director of Parkd during the quarter ended 31 March 2018.

ABOUT PARKD GROUP

Parkd has intellectual property rights to aspects of an innovative lightweight concrete "modular" car parking system. The modular aspect of the system and minimising the structural weight provides the ability to relocate the car park or adapt it to parking demands by adding or subtracting to the structural levels of the car park.

The Parkd Car Park System is currently designed for single or multi rise arrangements for up to 6 levels including ground level. The Parkd Car Park System will be prefabricated offsite with the potential to reduce construction time and construction cost when compared to traditional methods.
