

## APPENDIX 4C COMMENTARY

### Quarter ended 31 March 2021

**PERTH AUSTRALIA, 30 April 2021: PARKD Ltd (“PARKD” or the “Company”) (ASX:PKD)** lodges the attached Appendix 4C Quarterly Cashflow Report for the 3 months period ended 31 March 2021 and provides the following update on its activities.

This quarter PARKD completed a number of small contracts for private developers and was engaged by St John Of God Health Care to provide technical advisory services relating to the development of multi-level car parks to improve parking amenity whilst minimising disruption to the hospital operation.

PARKD remains engaged with State and Federal Governments and through building contractors pursuing tenders for the construction of multi-level car parks nationally. PARKD continues to work with the Penrith City Council and is well positioned to engage in ‘shovel ready’ Government projects in the transport and health sectors.

The Company issued 10,091,647 fully paid shares pursuant to the non-renounceable entitlement offer in March 2021 raising \$504,582 (before costs). Subsequent to the quarter end, the Company placed the shortfall offer of 14,958,486 ordinary fully paid shares at 5.0 cents per share which will raise \$747,924 (before costs). The Directors are pleased with the level of acceptances of the offer and thank existing shareholders who supported this offer and welcome the new Institutions and sophisticated investors who participated in the shortfall placement.

Net operating cash outflows for the quarter totalled \$249,000 and the Company’s cash reserves at 31 March 2021 was \$1,256,000. The Company received \$12,000 of Government grants and allowances under the current COVID-19 relief initiatives. Cash flow from income relating to the recent engagements is expected in the next quarter. Expenditure for the quarter consisted of general project, administrative and compliance costs that were consistent with the Company’s stated business objectives.

With regards to item 6.1 of the Appendix 4C totalling \$66,000, the Company advises that it consisted of salary and superannuation payments to directors with the exception of the Chairman who forgave his remuneration during the quarter.

This announcement has been approved for release by the board of directors of PARKD Limited.

#### **ABOUT PARKD LTD**

PARKD has intellectual property rights to aspects of an innovative lightweight concrete “modular” car parking system. The modular aspect of the system and the minimising of structural weight provides the ability to relocate the car park or adapt it to parking demands by adding or subtracting to the structural levels of the car park. The PARKD Car Park System is currently designed for single or multi rise arrangements of up to 6 levels including ground level. The PARKD Car Park System is prefabricated offsite with the potential to reduce construction time, cost and site disruption when compared to traditional construction methods.
