

## QUARTERLY ACTIVITIES REPORT - APPENDIX 4C

### Quarter ended 30 September 2021

**PERTH AUSTRALIA, 29 October 2021: PARKD Ltd (“PARKD” or the “Company”) (ASX:PKD)** lodges the attached Appendix 4C Quarterly Cashflow Report for the 3 months period ended 30 September 2021 and provides the following update on its activities for the quarter.

In this quarter the Company made significant steps forward in both its operational activity and strategic direction and presents the following update.

Operationally the company secured and delivered several technical design reports to develop multistorey car parks for clients including St John of God Private Hospital, Healthscope Private Hospitals, Coxon Group, Base Properties, John Hughes Group and Bendigo City Council. Whilst these technical advisory works are considered in the ordinary course of business for the Company it is promising to see the level of enquiry strengthen and progress to consulting contracts.

The execution of a construction contract with John Hughes Group marks a significant milestone and achievement for the company. The project will see the PARKD System utilised as a mezzanine structure within an existing warehouse great improve the operational function of the space and business in which it relates.

Strategically the Company announced a partnership with Axiom Properties (ASX: AXI) to explore funding opportunities for car park developments nationally. This agreement was formed to capitalise on the benefits of the PARKD System and Axiom’s funding pathways to pursue and explore CBD public parking, retail commercial, commercial industrial and public and private institutional developments under a lease or operating model.

To support the current and forecast construction projects the Company made an application as a Building Contractor in Western Australia and employed Simon Amos as General Manager Construction for the delivery and management of projects. Simon joins the team as a highly experienced Executive having been employed by Tier 1 contractors and recently as CEO Australia for Construction Technology company Fast Brick Robotics (ASX: FBR).

Net operating cash outflows for the quarter totalled \$249,000 and the Company’s cash reserves at 30 September 2021 was \$1,449,000. Revenue for the quarter comprised fee income for technical services provided and expenditure for the quarter consisted of general project, administrative and compliance costs that were consistent with the Company’s stated business objectives.

With regards to item 6.1 of the Appendix 4C totalling \$66,000, the Company advises that it consisted of salary and superannuation payments to directors with the exception of the Chairman who forgave his remuneration during the quarter.

This announcement has been approved for release by the board of directors of PARKD Limited.

PARKD has intellectual property rights to aspects of an innovative lightweight concrete “modular” car parking system. The modular aspect of the system and the minimising of structural weight provides the ability to relocate the car park or adapt it to parking demands by adding or subtracting to the structural levels of the car park. The PARKD Car Park System is currently designed for single or multi rise arrangements of up to 6 levels including ground level. The PARKD Car Park System is prefabricated offsite with the potential to reduce construction time, cost and site disruption when compared to traditional construction methods.
