QUARTERLY ACTIVITIES REPORT - APPENDIX 4C Quarter ended 30 September 2022

PERTH AUSTRALIA, 31 October 2022: PARKD Ltd ("PARKD" or the "Company") (ASX: PKD) lodges the attached Appendix 4C Quarterly Cashflow Report for the 3 months period ended 30 September 2022 and provides the following update on its activities for the quarter.

This quarter saw the Company achieve practical completion for its project with the John Hughes Group following the delivery of final fit-out works after substantial completion reported in the previous quarter. Successfully delivering the project to a program and budget further demonstrates the advantages of building with the PARKD Construction System and it's patented Continuously Voided Beam (CVB tm) technology and the advantages against traditional forms of construction.

In this quarter the Company also signed a contract for Stage 1 works for the design and documentation of a new 3 level integrated Audi retail centre. The new dealership design will follow the latest Audi Corporate Identity guidelines that aspire to outcomes such as sustainable construction methods, digital interfaces and electric vehicle charging.

The application of PARKD's IP for the construction of dealership developments presents a fantastic opportunity for the company to further strengthen niche solutions to the Automotive Retail Sector by assisting manufacturer standardise their dealership modernisation through modern methods of construction and designs to maximise customer experience.

This project will deliver approx. 3600m² of suspended structure including sales, servicing, parts and vehicle wash in the same facility.

News was also received regarding the Company's Patent applications, for its CVB technology, from several regions around the world with confirmation that registrations were granted in Japan and the USA.

Other significant achievements in the quarter include the commencement of paid technical design works for a multi-national heavy industry vehicle manufacturer for a multi-level car park at their industrial office, sales and service centre.

Net operating cash outflows for the quarter totalled \$195,000 and the Company's cash reserves at 30 September 2022 was \$731,000. Revenue for the quarter comprised fee income for technical services provided to various clients and progress claims received in the quarter on the John Hughes and Audi Myaree Projects. Expenditure for the quarter consisted of general project, administrative and compliance costs that were consistent with the Company's stated business objectives.



With regards to item 6.1 of the Appendix 4C totalling \$71,000, the Company advises that it consisted of salary and superannuation payments to directors.

ABOUT PARKD LTD (ASX: PKD)

PARKD has intellectual property rights to aspects of an innovative lightweight concrete "modular" car parking system. The modular aspect of the system and the minimising of structural weight provides the ability to relocate the car park or adapt it to parking demands by adding or subtracting to the structural levels of the car park. The PARKD Car Park System is currently designed for single or multi rise arrangements of up to 6 levels including ground level. The PARKD Car Park System is prefabricated offsite with the potential to reduce construction time, cost and site disruption when compared to traditional construction methods.
