

## QUARTERLY ACTIVITIES REPORT - APPENDIX 4C Quarter ended 31 March 2023

**PERTH AUSTRALIA, 28 April 2023: PARKD Ltd (“PARKD” or the “Company”) (ASX: PKD)** lodges the attached Appendix 4C Quarterly Cashflow Report for the 3 months period ended 31 March 2023 and provides the following update on its activities for the quarter.

During the quarter the company secured several new feasibility advisory contracts and enquiries for the development of multi-level carpark nationally including NSW Port Authority, Bethesda Hospital, Sultan Group, John Hughes Group and others. The level of enquiry has increased significantly in the past 2 quarters and this is reflected in the revenues resulting from Technical Advisory contracts.

Significant progress was made in the testing and development of a new concrete slab system in collaboration with Fielders/Bluescope under a Heads of Agreement and we anticipate final independent testing to be complete by Curtin University in the next quarter. The development of this slab system, in conjunction with our Continuously Voided Beam (CVB<sup>™</sup>) technology, will allow PARKD to offer a complete Kit-of-Parts structural system that could be containerised and simply assembled worldwide.

Stage 1 contract design works for Audi Centre Myaree were submitted to the client and the Company awaits instruction to proceed with final contract documentation and pricing of construction works.

Net operating cash outflows for the quarter totalled \$10,000 and the Company's cash reserves at 31 March 2023 was \$681,000. Revenue for the quarter comprised fee income for technical services provided to various clients and progress claims in the quarter on the Audi Myaree Project. The 2022 Research and Development rebate of \$240,000 was received and expenditure for the quarter consisted of general project, administrative and compliance costs that were consistent with the Company's stated business objectives.

With regards to item 6.1 of the Appendix 4C totalling \$78,000, the Company advises that it consisted of salary and superannuation payments to directors with the exception of the Chairman. The Chairman's remuneration for the quarter has been accrued but not paid and the Chairman may choose to elected to receive his remuneration by issue of shares in lieu of cash payment subject to required shareholder approval as was previously done for the half year to 31 December 2022.

PARKD has intellectual property rights to aspects of an innovative lightweight concrete “modular” car parking system. The modular aspect of the system and the minimising of structural weight provides the ability to relocate the car park or adapt it to parking demands by adding or subtracting to the structural levels of the car park. The PARKD Car Park System is currently designed for single or multi rise arrangements of up to 6 levels including ground level. The PARKD Car Park System is prefabricated offsite with the potential to reduce construction time, cost and site disruption when compared to traditional construction methods.
